Cats Exclusive's "Deposit" Guidelines

- ❖ A "deposit" is defined as at least \$20 in cash given to Cats Exclusive to hold a cat/kitten being considered for adoption for the 24-48 hour application process. (If the amount is paid in full in advance, that can be paid in cash or by credit card and act as a deposit.)
- ❖ A deposit is not valid unless there is an application on the applicable cat/kitten. If an incomplete application is given, you have until the end of business of the day of the deposit to provide the rest of the necessary information, or the deposit becomes invalid.
- ❖ A deposit holds a cat/kitten from being shown or adopted during the 24-48 hour typical time period it takes to process your application. The 24-48 hours does NOT include our closed business days.
- ❖ If the 24- 48 hour process takes longer due to incorrect or missing information on an application, a deposit becomes invalid. If the process takes longer due to Cats Exclusive's busy schedule, a deposit's time period extends through the process as necessary.
- ❖ A deposit goes toward the adoption fee of a cat/kitten.
- ❖ If the application is approved, but the person decides not to take the cat/kitten for any reason other than his/her health, that deposit becomes non-refundable and acts as a donation to Cats Exclusive.
- ❖ A deposit is refundable if and only if the application is denied.
- ❖ If a deposit becomes invalid for any reason, the monies received as the deposit can still be put toward the adoption of any Cats Exclusive cat/kitten, but the originally held cat/kitten can be shown for adoption.
- ❖ A deposit and application put on a cat with an application, but no deposit trumps the "no deposit" application.
